TEMPORARY TRAFFIC REGULATION NOTICE 2026**

NOTICE IS HEREBY GIVEN that **MONMOUTHSHIRE COUNTY COUNCIL** of County Hall, The Rhadyr, Usk, NP15 1GA ("the Council") **Intends to make** an order pursuant to the powers conferred by Section 14(1)(a) of the Road Traffic Regulation Act 1984

1. The Order shall come into operation on the **11th May 2026** and will continue to be in force for a period not exceeding 18 months or until the works which it is proposed to carry out have been completed, whichever is the earlier. It is anticipated that the works will be completed **between 11th May 2026 and 15th May 2026, operating between 09:00– 15:30.**
2. The order is necessary **for BT Cabling works to take place** in a safe manner at the location. Reasonable access will be maintained for properties fronting the affected lengths of road during the period of the closure.
3. The effect of the order will be to temporarily close **a section of Brynderi Road, Brynderi, Monmouthshire**, from its junction with Tre-Llwyfan Lane for ~1.15km.
4. A signed diversionary route will be in place as follows:- **Brynderi Road, B4233, Whitecastle Road B4521 and vice versa.**
5. This order may be cited as the **Brynderi Road, Brynderi, Monmouthshire Temporary Traffic Regulation Order 2026**
6. By virtue of Section 16(1) of the Road Traffic Regulation Act 1984 a person who contravenes a restriction or prohibition imposed under Section 14 of the Act shall be guilty of an offence.

1. Daw'r Gorchymyn i rym ar **11eg Mai 2026** a bydd yn parhau i fod mewn grym am gyfnod nad yw'n hwy na 18 mis neu nes bod y gwaith y cynigir ei wneud wedi'i gwblhau, pa un bynnag yw'r cynharaf. Rhagwelir y bydd y gwaith yn cael ei gwblhau **rhwng 11eg Mai 2026 a'r 15fed Mai 2026, gan weithredu rhwng 09:00 – 15:30.**
2. Mae'r Gorchymyn yn angenrheidiol er mwyn **i BT wneud gwaith yn gosod ceblau** mewn modd diogel yn y lleoliad. Bydd mynediad rhesymol yn cael ei gynnal ar gyfer eiddo sydd ar hyd y ffyrdd a effeithir arnynt tra y bydd yr heol ar gau.
3. Effaith y Gorchymyn fydd cau dros dro **ran o Heol Brynderi, Brynderi, Sir Fynwy**, o'r gyffordd gyda Lôn Tre-Llwyfan am ~1.15km.
4. Bydd llwybr dargyfeirio fel a ganlyn: **Heol Brynderi, B4233, Heol Whitecastle, B4521 ac i'r gwrthwyneb.**
5. Gellir enwi'r Gorchymyn hwn fel **Gorchymyn Rheoleiddio Traffig Dros Dro Heol Brynderi, Brynderi, Sir Fynwy 2026.**
6. Yn sgil Adran 16(1) Deddf Rheoleiddio Traffig Ffordd 1984 bydd person sy'n torri cyfyngiad neu waharddiad a osodir dan Adran 14 y Ddeddf yn euog o drosedd.
